Finding Company Profiles

Business Source Complete is one of the library's strongest business resources. In addition to articles it is also a good place to find company profiles which provide a description of the company, key employees, products and services, revenue information, SWOT analysis, and more. *Note: not all company profiles contain the same information.*

- The database's search page will open up. In the menu above the search boxes place the cursor on **More**, and select **Company Profiles** from the drop down list.




Image of Company Profile link






Image of Download PDF link, save, print, and email icon




Image of Back link

Finding Company Information

The Company Information search feature in the Business Source Complete database will allow you to search for information about specific companies by name. You can also generate lists of companies using criteria such as company type, location, and NAICS code. NAICS codes are 6-digit codes used by the U.S. government to classify companies that sell such similar goods and services they are in direct competition with each other.

- Click **Business Source Complete** from the list on the library homepage.

- The search page will open. In the menu above the search boxes, click on **Company Information** to open the Company Information search page.




Image of Company Information link

- For example, you could choose to limit your results to publicly traded companies in the U.S. To do so, scroll down until you see the **U.S. Company Type** heading.
- Then click in the box next to **Public** and a checkmark will appear when this option has been selected.

NAICS by Description

EBSCO has aligned periodical and journal content to the North American Industry Classification System (NAICS).

Currently, whenever possible, periodical and journal content has been assigned to one or more 6-digit NAICS codes. At this time EBSCOhost supports searching only by 6-digit NAICS codes. This code is visible in the citation alongside the field descriptor NAICS/Description. The NAICS code is followed by a brief descriptor.

Note:

- Not every NAICS code will be associated to an article. The very nature of periodical and journal content does not always have a match to certain government-identified industry areas.
- EBSCO used the information found at the [U.S. Census Bureau's NAICS web page](#) to assist in creating this page.






Image of ABI Inform Collection link




Image of full text link




Image Download PDF link, cite, email, print, and save icons

Web Resources

Public companies in the United States are required by law to report financial information to the U.S. Securities and Exchange Commission (SEC). These reports are made available to the public on the SEC's website, in their Electronic Data Gathering, Analysis, and Retrieval system (EDGAR).

Of these reports, the annual report, known often by its form name of 10-K, is one of the most useful to locate key financial information. Information about a company's products, services, and strategy can also usually be found in an annual report under the section titled Item 1 - "Business".

Follow the steps below to learn how to find annual reports (10-K) for publicly traded companies in the U.S.

- Visit the SEC EDGAR website: <https://www.sec.gov/edgar/searchedgar/companysearch.html>
- Enter the company name in the search box under Company name, or the Ticker or CIK under the Fast Search box. Click **Search**.
